

BLACK MARKET CLASH - THE STORY OF THE CLASH

WIN FIVE CLASSIC CLASH ALBUMS ON 180G VINYL TERMS AND CONDITIONS

1. Promoter

The promoter is **Pop Preservation Society Pty Ltd, ABN 53 659 359 930** ("Promoter").

2. Promotion

The promotion is conducted in connection with **Black Market Clash - The Story of The Clash**, being held at **The Curtin, Carlton, Victoria, on Friday 2 October 2026** ("Event").

The promotion is a trade promotion lottery conducted in Victoria.

There is no separate charge to enter the promotion. Entry is available to eligible holders of a valid paid ticket to the Event in accordance with these Terms and Conditions.

3. Promotion Period and Entry Period

The promotion applies to eligible paid tickets purchased for the Event, including:

- (a) eligible tickets purchased before the promotion was announced;
- (b) eligible tickets purchased after the promotion was announced; and
- (c) eligible tickets purchased at the venue on the night of the Event before entries close.

Entry into the promotion occurs at The Curtin on Friday 2 October 2026 when an eligible ticket holder is issued a numbered competition stub.

Numbered competition stubs will be issued when eligible prepaid tickets are presented for admission or, in the case of eligible tickets purchased at the venue, following purchase.

Entries close immediately before the prize draw during intermission on Friday 2 October 2026.

No competition stubs will be issued after entries have closed.

4. Eligibility

Entry is open to a person who:

- (a) holds a valid paid ticket to the Event;
- (b) attends the Event at The Curtin on Friday 2 October 2026;
- (c) presents their eligible prepaid ticket for admission, or purchases an eligible paid ticket at the venue before entries close;
- (d) receives a numbered competition stub before entries close; and
- (e) is present at The Curtin when the prize draw is conducted.

Complimentary tickets, guest-list admissions, promoter or venue passes and any other admission for which no ticket price has been paid are not eligible.

Each eligible paid ticket entitles the holder to **one entry only**.

5. How to Enter

An eligible ticket holder will be issued one numbered competition stub at The Curtin before entries close.

One part of the numbered stub will be given to the entrant. The corresponding numbered part will be placed into the prize draw.

The entrant must retain their numbered stub until the draw has been completed and the winner has been verified.

There is no additional charge to enter the promotion beyond the purchase of the eligible Event ticket.

Every valid entry has a random and equal chance of being selected.

6. Prize

There is **one prize**, consisting of the following five new vinyl albums by The Clash:

- *The Clash* - **1LP 180g vinyl**
- *Give 'Em Enough Rope* - **1LP 180g vinyl**
- *London Calling* - **2LP 180g vinyl**
- *Sandinista!* - **3LP 180g vinyl**
- *Combat Rock* - **3LP 180g vinyl**

The five albums constitute one prize and will be awarded together to one winner.

The total advertised retail value of the prize is approximately **AUD \$400**.

The prize is not transferable, exchangeable or redeemable for cash.

If any component of the prize becomes unavailable due to circumstances beyond the Promoter's control, any substitution will be made in accordance with applicable Victorian requirements.

7. Prize Draw

The prize draw will take place **during intermission at Black Market Clash - The Story of The Clash at The Curtin, Carlton, Victoria, on Friday 2 October 2026**.

Entries will close immediately before the draw.

The exact time of the draw will depend on the running time of the Event.

The winning numbered stub will be selected randomly from all eligible entries received before entries close.

Each eligible entry will have a random and equal chance of being selected.

The winning number will be announced at the Event.

8. Requirement to be Present

Entrants must be present at The Curtin at the time of the prize draw to be eligible to win.

Entry into this promotion and the prize draw occur on the same day and at the same place.

Attendance at the Event and presence at the time of the draw are conditions of entry.

9. Determination and Verification of Winner

The holder of the numbered competition stub corresponding with the number randomly selected will be the provisional winner.

To claim the prize, the provisional winner must:

- (a) be present at The Curtin at the time of the draw;
- (b) come forward following announcement of the winning number;
- (c) present and surrender the original corresponding numbered competition stub; and
- (d) provide their **full name and either an email address or mobile telephone number** to the Promoter for the purposes of verifying and recording the prize award and providing written notification of the win.

The Promoter may take reasonable steps to verify the validity of the winning stub and the person's eligibility under these Terms and Conditions.

Once eligibility has been verified, the entrant will be declared the winner.

The Promoter will provide the winner with written notification of the win.

10. Prize Claim and Collection

The winner must claim and take possession of the complete prize at The Curtin on Friday 2 October 2026.

Collection of the prize at the Event on the night is a condition of the promotion.

Following verification of the winner, the complete prize will be handed to the winner at the Event.

The prize will not be held for later collection, posted or delivered after the Event.

No additional fee or material cost will be imposed on the winner to accept the prize.

11. If a Winner Does Not Come Forward

If the holder of the winning numbered stub:

- (a) does not come forward within a reasonable period after the winning number is announced;
- (b) cannot produce and surrender the corresponding original numbered stub;
- (c) is not present at the Event;
- (d) does not satisfy the eligibility requirements;
- (e) declines the prize; or
- (f) does not agree to take possession of the prize at the Event,

the Promoter will make reasonable efforts at the Event to identify the holder of the winning number.

If those reasonable efforts are unsuccessful, the Promoter may conduct a further random draw from the remaining eligible entries.

The further draw will be conducted using the same random and equal-chance method.

The new winning number will be announced at the Event and the holder must be present and satisfy all requirements of these Terms and Conditions.

This process may be repeated until an eligible winner who is present claims and takes possession of the prize.

12. Invalid Entries

The Promoter may verify the validity of any entry and the eligibility of any entrant.

An entry may be declared invalid if it arises from a ticket that is cancelled, refunded, fraudulent, duplicated, complimentary or otherwise does not constitute an eligible paid ticket to the Event.

A competition stub that has been altered, duplicated, fraudulently obtained or otherwise compromised may be declared invalid.

A lost, destroyed or illegible competition stub will not ordinarily be replaced.

13. Winner Information and Privacy

For the purpose of verifying and recording the prize award, the winner must provide:

- (a) their full name;
- (b) either an email address or mobile telephone number; and
- (c) their winning numbered competition stub, which must be surrendered to the Promoter.

The Promoter will retain the surrendered winning stub together with the record of the winner and distribution of the prize.

The winner's information will be used only for purposes connected with administering the promotion, verifying the winner, providing written notification of the win, recording distribution of the prize and satisfying applicable legal and record-keeping requirements.

The information will not be used for unrelated marketing purposes without separate consent.

14. Winner Record

The Promoter may require the winner to sign a prize receipt or winner record confirming:

- (a) the winner's full name;
- (b) the winning competition stub number;
- (c) receipt of the five vinyl albums comprising the prize;
- (d) the date the prize was received; and
- (e) that the complete prize was received at the Event.

The winner's surrendered numbered stub may be attached to that record.

15. Record Keeping

The Promoter will retain the records required under applicable Victorian trade promotion lottery requirements. These records will include appropriate records relating to entries in the promotion and distribution of the prize. Required records will be retained for **three years after the promotion is finalised**.

16. Cancellation or Postponement

If the Event is cancelled, postponed or materially altered because of circumstances beyond the Promoter's reasonable control, the Promoter may make such changes to the promotion as are reasonably necessary and permitted by law.

Any material changes to the promotion will be communicated through an appropriate Pop Preservation Society or Black Market Clash communication channel where reasonably practicable.

Nothing in these Terms and Conditions limits any rights that cannot lawfully be excluded.

17. Liability

Nothing in these Terms and Conditions excludes, restricts or modifies any consumer guarantee, right or remedy under the Australian Consumer Law or any other applicable law that cannot lawfully be excluded, restricted or modified.

To the extent permitted by law, the Promoter is not responsible for loss, damage, delay or failure arising from circumstances outside its reasonable control affecting the administration of the promotion.

18. Promoter's Decisions

Subject to applicable law, decisions of the Promoter concerning administration of the promotion, validity of entries, verification of eligibility and conduct of the draw are final.

Nothing in this clause limits any rights available under applicable law.

19. Acceptance of Terms and Conditions

Participation in the promotion constitutes acceptance of these Terms and Conditions.

20. Governing Law

These Terms and Conditions are governed by the laws of Victoria, Australia.
